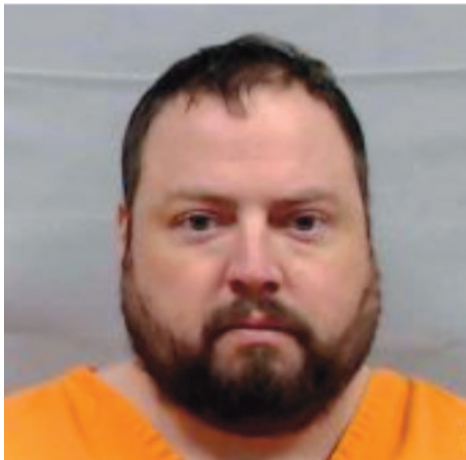




Man Arrested on Assault Charges After Allegedly Driving Tractor into Barn

JUMPING BRANCH W.Va. (Hinton News) - According to a criminal complaint, on Sunday, Dec. 7, a trooper was dispatched through Summers County 911 to a call in the vicinity of Amick Farm Road for a

call involving a disturbance with possible shots fired. When the trooper was on the way to the call, a Hinton city officer reportedly told the trooper he was on scene and that an individual was shut up inside the barn and refused to come out. The trooper arrived on scene with another trooper and was reportedly told the individual was in the barn at the end of the road and refused to come out. The troopers arrived at the barn and attempted to make contact with the individual by way of the PA system on the police cruiser. About this time, the criminal complaint reports that they see the individual come out of the barn with both hands in the air. The trooper then detained the individual. Once the person was detained, the trooper asked what happened, and the individual allegedly said the ac-

cused, later identified as Zina Jason Angell, drove a tractor into the barn in which he was residing. He said he had a camper he was living in inside the barn. According to the criminal complaint, the victim told the trooper that Angell tried to enter the barn from the side door but couldn't, so he took the tractor with hay spikes on the front to the side of the barn. According to the victim, that's approximately 15 yards from the bedroom of the camper where the victim was lying. The victim reportedly advised that once the tractor made its entrance into the barn, he got his pistol and fired 5 shots in the vicinity of where Angell was driving the tractor. The victim told the trooper he felt his life was in immediate danger once Angell drove the tractor into the barn trying to reach him. The victim allegedly

stated that he had no safe exit routes once Angell made an entrance with the tractor into where he was residing. The victim also said Angell had been coming around threatening to kill him, according to the criminal complaint. The trooper then spoke to Angell, who reportedly told him he thought the victim didn't have the right to still be living in the barn. He allegedly went on to say he had been attempting to remove the door to make entry into the barn. At the point the tractor made entry into the barn, he heard gunfire. At this time, the trooper placed Angell under arrest on assault charges. He was transported to WVSP Hinton Detachment for processing, then transported to Southern Regional Jail. At the time of publishing, Angell is not listed as an inmate at SRJ.

Alleghany County Off-Duty Deputy Snags Two from Alderson W.Va.

ALLEGHANY COUNTY Va. (Hinton News) - The Alleghany Highlands have recently experienced an increase in reports of packages and mail being taken during the late-night and early-morning hours. Complainants described the suspects as traveling in a white sedan with black rims, stopping at mailboxes and removing packages or any mail that appeared to contain items of value. After numerous complaints on Facebook, the Alleghany County Sheriff's

Office issued a request for citizens who noticed missing mail or packages to file a report. On December 9, 2025, Sheriff Moore authorized multiple surveillance teams to be stationed throughout western Alleghany County during overnight hours in hopes of identifying the individuals responsible. At approximately 2:00 a.m. on December 10, 2025, off-duty Lieutenant Doug Altizer heard a vehicle stop near his residence. Looking outside, he observed a white sedan with black rims parked at his mailbox. Lt. Altizer quickly dressed, entered his vehicle, and began following the suspicious car. He caught up with it near the 5300 block of Indian Draft Road, where he witnessed two individuals going through a row of mailboxes. Using his department radio, he immediately requested additional units to assist. Upon noticing Lt. Altizer's vehicle approaching, the suspects returned to their own car and fled. Lt. Altizer continued to follow them until responding deputies executed a felony traffic stop at the intersection of Jackson River

Road and Foxaway Lane. Deputies took Kathleen Marie Davis, 22, and Corey Shane Martin, 23, both of 22 Eynn Subdivision, Alderson, West Virginia, into custody. The suspects admitted to stealing mail in the Alleghany Highlands for at least two weeks, stating that "times were tough" and they decided to take items belonging to others. They are currently facing 17 felony counts of mail theft. Investigators from the U.S. Postal Service, Bath County, and West Virginia are continuing to conduct interviews and coordinate evidence related to the case. Both Davis and Martin have been cooperative. A subsequent search of the vehicle yielded multiple pieces of mail and packages addressed to residents in the Indian Draft and Johnson's Creek areas, along with \$413.00 in cash. Both individuals were taken into custody and charged with 18 felony counts under Virginia State Code §18.2-110.1. They are currently being held at the Alleghany County Regional Jail. This matter remains under investigation. Anyone with additional informa-

tion is asked to contact the Alleghany County Sheriff's Office. Lt. Altizer commented, "I am happy that I was able to assist and finally get a cup of coffee." Lt. Altizer serves as the Assistant Chief Jailer at the Regional Jail, and his quick actions played a crucial role in helping the Alleghany County Sheriff's Office save Christmas for many citizens. The Sheriff's Office expresses its gratitude for his efforts. Sheriff Moore stated that he is pleased these suspects were apprehended, noting that "times are tough for our citizens also, and they aren't out here stealing other people's stuff." He credited the successful arrest to the quick thinking and swift response of all deputies and law enforcement personnel involved. Sheriff Moore emphasized that the department takes these crimes seriously and will pursue prosecution to the fullest extent of the law. Christianity Before Alexander Campbell

(Part 3)

(Last week we continued looking at some of the history concerning churches of Christ in other countries before Alexander Campbell. We will complete that little bit of history today and then invite each one to examine the records and make your own conclusion regarding Christ’s church.)

Manchester, England

This small congregation was established in 1810 with only three members. Elders and deacons were appointed in 1817. The next year they numbered 33. Aside from three meetings each Lord’s day, they also met twice during the week for prayer, scripture reading and teaching. They attended to the observance of the Lord’s Supper every Sunday afternoon. (Reference: *The Christian Baptist*, Volume 5, Issue 7, February 1828).

Dublin, Ireland

The Stephen Street congregation in Dublin was established in 1810 and consisted of 100 members in 1818. Their order of services was almost identical with the church in New York. They had not yet appointed elders because they could not agree upon the necessary qualifications. While explaining why they were more tolerant of differing opinions on Bible themes, they said, “that all blindness, as to apostolic precepts, is chargeable on the folly and slowness of our hearts. The same folly and slowness of heart prevented the apostles from receiving many truths at the mouth of Jesus; but as their folly and slowness of heart was not indicative of a rejection of Christ, so neither in these days do we apprehend that in the folly and slowness of professors to receive many truths in the apostolic records, is in all cases indicative of a rejection of their authority; and as the Lord bore with the apostles, we see not but his example was recorded for our imitation.” (Reference: *The Christian Baptist*, Volume 5, Issue 8, March 1828).

Conclusion

While these congregations were still lacking in some areas, the progress they made towards restoring the ancient order of things is important. One more item worthy of note is the tombstone of William Rogers at the Cane Ridge meetinghouse near Paris, Kentucky. It simply reads:

William Rogers

Born In Campbell Co., VA. July 7, 1784,
Removed With His Father To
Caine Ridge, Bourbon Co., Apr. 1798
United With The Church Of Christ
At Caine Ridge In 1807
Died Feb. 15, 1862
In The 78th Year Of His Age

At the time William Rogers “united with the church of Christ at Caine Ridge,” Alexander Campbell was but a young man in his teens, still living in Ireland. The “church of Christ” was not started by Campbell, nor does it follow his teaching. The church of Christ (Rom. 16:16) was established at Jerusalem on the first Pentecost after the death of Christ—you can read of it in the second chapter of the book of Acts. The seed of the Kingdom is still the word of God (Luke 8:11).

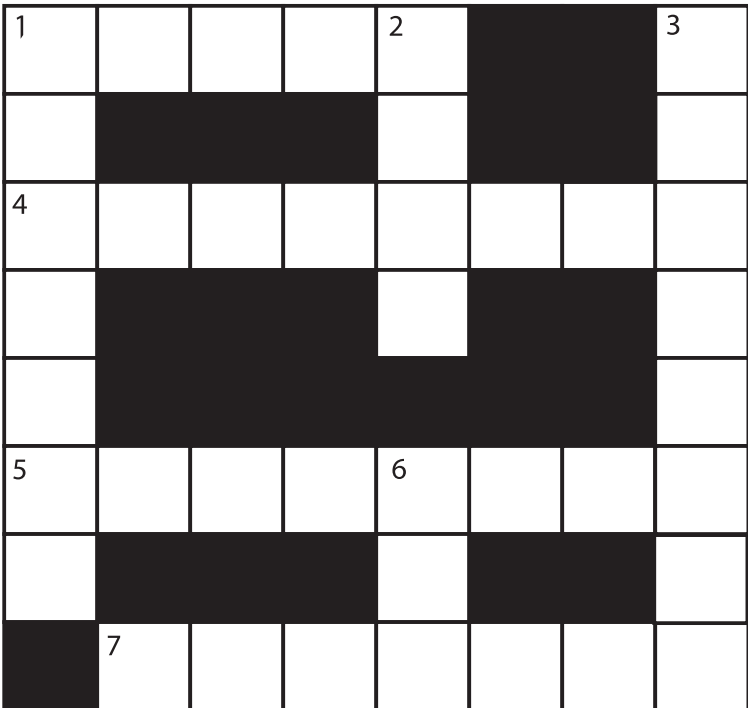

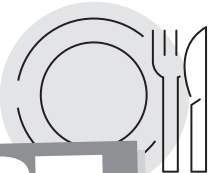

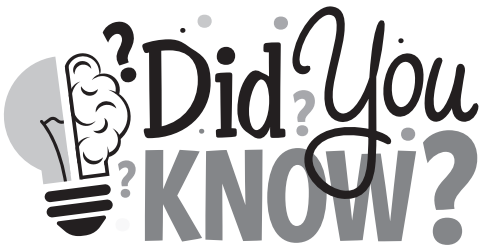

Dear Recycling Santa, Thanks for the excellent suggestions for reusing peanut butter jars. There must be other kinds of jars that are also good for reusing. Readers, I'd love to have some more suggestions to add to this list. Please email them to Recyclelady7@gmail.com. Recycling, reusing, reducing and repurposing items of any kind helps save our environment and reduces waste sent to the Greenbrier County Landfill. Last month, 3,675 TONS (7,350,000 pounds!) of trash were brought to the landfill. During this same month, 93.2 TONS (186,400 pounds!) of recycled items were shipped out by the Recycling Center. Although 93.2 tons sounds like a lot of recycling, it is only 2.5% of the total amount of trash generated. Thanks to all our dedicated recyclers, these 93.2 tons of recyclables are not part of the landfill.

Dear Recycle Lady, With Christmas rapidly approaching my mailbox is full of requests for charitable donations. Many of the organizations

include a pink, yellow, or blue return envelope. Are these envelopes recycled as magazines or office paper? Can't Contribute to All of Them

Dear Can't Contribute to All of Them, Most colored envelopes are recycled with magazines. To be sure, look at the inside of the envelope. If it is the same color as the outside, the envelope will be recycled with magazines. If the inside of the envelope is white, the envelope will be recycled with office paper. As with all colored paper, you can determine which way to recycle the paper by making a small tear. If the torn strip shows that the paper is colored throughout, the paper is recycled with magazines. If the tear reveals white paper inside, it recycles with office paper. If the inside of the envelope is gold foil, the envelope will not recycle at all.

Dear Recycle Lady, Most wrapping paper comes on a long roll. Can this roll be recycled with cardboard? Gift Wrapper

Dear Gift Wrapper, Yes, the wrapping paper tube can be recycled with cardboard, as well as all those gift boxes you find under the tree after opening packages. If they are not reusable, the boxes can also be recycled with cardboard; just be sure they are clean, dry, and empty. Besides recycling, the empty wrapping paper tube can be reused to store used wrapping paper for safekeeping until its next use.

Winter Weather Poses Increased
Risks for Individuals Living with
Alzheimer’s and Other Dementias

CHARLESTON, W.Va. (Hinton News) — As winter continues, colder temperatures, snow, ice and early nightfall can pose serious risks for the 38,100 individuals living with Alzheimer’s and other dementias in West Virginia. For their 65,000 unpaid caregivers, the season brings added stress and challenges in ensuring their loved ones remain safe.

“People living with Alzheimer’s and

other dementias are especially vulnerable during winter weather,” said Teresa Morris, program director for the Alzheimer’s Association West Virginia Chapter. “Impaired

judgment and difficulty communicating discomfort can make it harder for them to respond appropriately to cold or hazardous conditions. That’s why it’s so important for

caregivers to take extra precautions.”

In addition, Alzheimer’s disease can cause those living with any form of dementia to lose their ability to recognize familiar places and faces, making it common for a person living with dementia to wander or become lost or confused about their location, increasing the danger of cold weather.

The Alzheimer’s Association offers the following tips to help families prepare and protect loved ones during the winter months:

Be Prepared: Monitor weather forecasts and have emergency plans in

SUMMERS COUNTY W.Va. (Hinton News) - In this week’s piece, I will be asking for your help identifying the location of these photos. These photos belonged to Oscar Hutchison. Oscar was an early photographer in Summers County, and he had a studio in the city of Hinton around the turn of the century. Oscar had

a stroke and died at an early age. His Grandson, Tom Huutchison, recently gave these two photos to me to add to my collection. Tom is a fellow Summers County historian, as well as a retired teacher whom you or your parents may have had in school. Now for the two photos in question. First, we will address the photo of the early house. It is of a two-story

board and batten home. It resembles the early Silas Hinton home that was in Avis. The Hinton house did not have a two-story porch across the front like the one in the photo; it only had a two-story half porch. The 2nd photo is of an early dirt road scene with a two-story house on the left. Again, I do not know anything about this photo, but looking at it more closely, there is a board

fence to the right. I am merely making a hypothesis here, but it appears this could possibly be along a stretch of riverbank or something. I have to wonder if this could be in Avis before it developed into the way it now looks. But looking at it even closer, there appears to vaguely be a very large structure in the center. I can make out what looks to be a window and chimney. There was nev-

er a large wooden structure like this in Summers County that I am aware of, other than the first Pence Springs Hotel. I am sorry I can’t provide any “concrete” information about

place for storms or power outages. Dress Warmly: Ensure individuals wear dry, layered clothing and cover exposed skin to prevent hypothermia. Prevent Slips: Assume all surfaces are slick. Assist with walking and encourage slower, shorter steps to reduce fall risk. Maximize Daylight: Shorter days and reduced sunlight can increase confusion. Keep indoor spaces well-lit and plan outdoor activities during daylight hours. Monitor for Wandering: Cold weather and early darkness heighten the risks of wandering. Watch for signs of restlessness or agitation, especially during late afternoon and evening hours. Ask for Help: According to an Alzheimer’s Association survey, 84% of caregivers want

more support. Don’t hesitate to ask family, friends, or neighbors for help with errands, snow removal, or other tasks. Additional winter safety tips and resources are available at alz.org/safety. For immediate support, the Alzheimer’s Association 24/7 Helpline is available at 1.800.272.3900, offering free, confidential assistance—day or night, even on holidays. For the first time, the number of people living with Alzheimer’s disease in the U.S. is more than 7 million. That includes 38,100 in West Virginia, according to the 2025 Alzheimer’s Disease Facts and Figures. Deaths due to Alzheimer’s more than doubled (142%) between 2000 and 2022, while deaths from the leading cause of mortality (heart disease) de-
